CAPTURED VIETCONG SHOWN TO JOURNALISTS 27 MARCH

Phnom Penh Domestic Service in Cambodian 0500 GMT 27 Mar 75 BK

[Text] Two Vietcong soldiers captured by our forces in Svay Rieng Province on 4 March, were presented at 0930 today before domestic and foreign journalists. The two are: (Dang Minh The) alias (Ba The), Vietnamese national, 45 years of age, born in (Tran Bang), Tay Ninh Province, South Vietnam. He served in the Vietminh forces since 1945 and infiltrated into Cambodia after 1970 as a battalion commander in charge of Battalion CIB-230. The other, (Tran Van Pho), South Vietnamese national, aged 25, son of (Tran Van Phat) and (Nguyen Thi Chu), born in Prek Sbauv village, Kompong Thom Province in the Khmer Republic, has served in the Vietcong forces since 1970 as a group commander and driver for (Dang Minh The).

Addressing the journalists, spokesman of the Cambodian National Armed Forces High Command Gen Am Rong said this is the first time since the 27 January signing of the Paris agreement that our forces have captured Vietcong soldiers in the Khmer Republic. The presentation ended after the two Vietcong soldiers were questioned by the journalists.

SIHANOUK 26 MAR STATEMENT NAMES MORE WAR CRIMINALS

[Text] Peking, March 27, 1975 (HSINHWA) -- Samdech Norodom Sihanouk, head of state of Cambodia in a statement yesterday reaffirmed the determination of the Cambodian people to struggle through to the end.

The statement was issued in connection with the fact that the United States recently instigated Long Boret to make an appeal, in the name of the "prime minister" of the new government of "Khmer Republic", to "the Cambodians of the other side" for a cease-fire, negotiations and a "national reconciliation".

The statement says: "Long Boret himself has been sentenced to death by the Cambodian people in the national congress (on February 25, 1975). "U.S. imperialism will be greatly mistaken if it believes that Long Boret knows better than Lon No1 [how] to soften the Khmer Rouge patriots' will to resistance and make them join his dirty 'republic'."

It says that although Hang Thun Hak, Pan Sothi, Sak Sutsakhan, Lon Non and other super-traitors were not sentenced to death by the Cambodian people's national congress, they are also real war criminals and will confess their crimes before the state courts of justice after the liberation of Phnom Penh.

The statement says: "In offering these fascist and extremely corrupt traitors, super war criminals and igonominious criminals as 'interlocutors' with the National United Front of Cambodia, the Royal Government of National Union of Cambodia and the Cambodian People's National Liberation Armed Forces, U.S. imperialism is insulting unpardonably the memory of the Cambodian patriots, men and women, who had sacrificed their lives for the most lofty and purest ideals of the Cambodian people."

The statement says: "The NUFC, the RGNUC, the CPNLAF and Norodom Sihanouk swear to fight to death against U.S. imperialism. We swear that we would never accept negotiation or compromise with U.S. imperialism and its henchmen as long as the breath of life remains with us."

The statement says: "If the U.S. aggressors again dare to embark on adventure against our people, they will be able to victoriously cope with this despicable and arch-criminal aggression."
